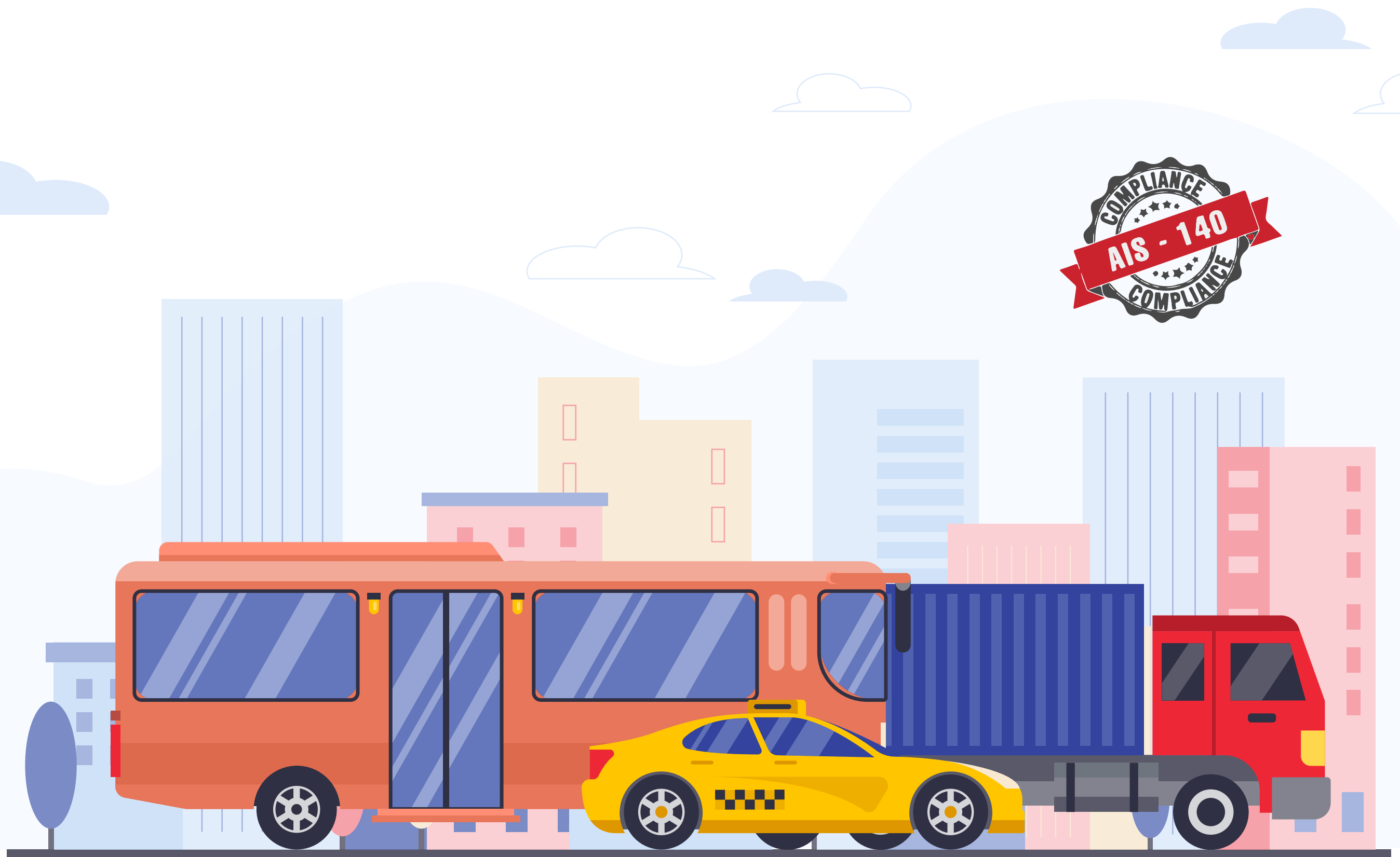

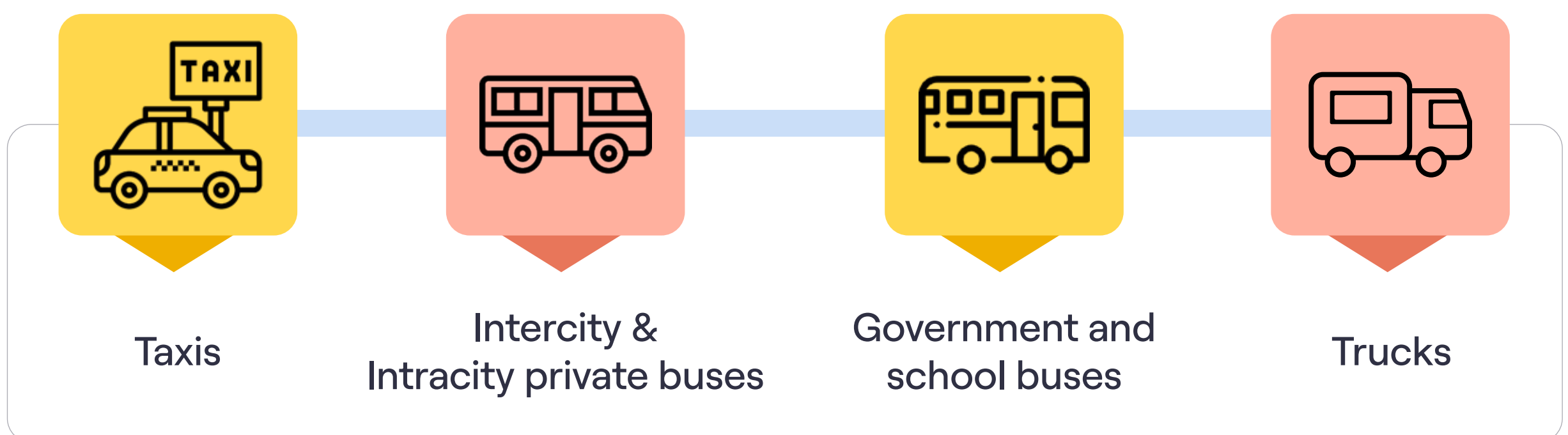

AIS 140 regulations are formulated to enable an Intelligent Transportation System in India, **ensuring the safety of passengers and tracking of your fleet** at all times.

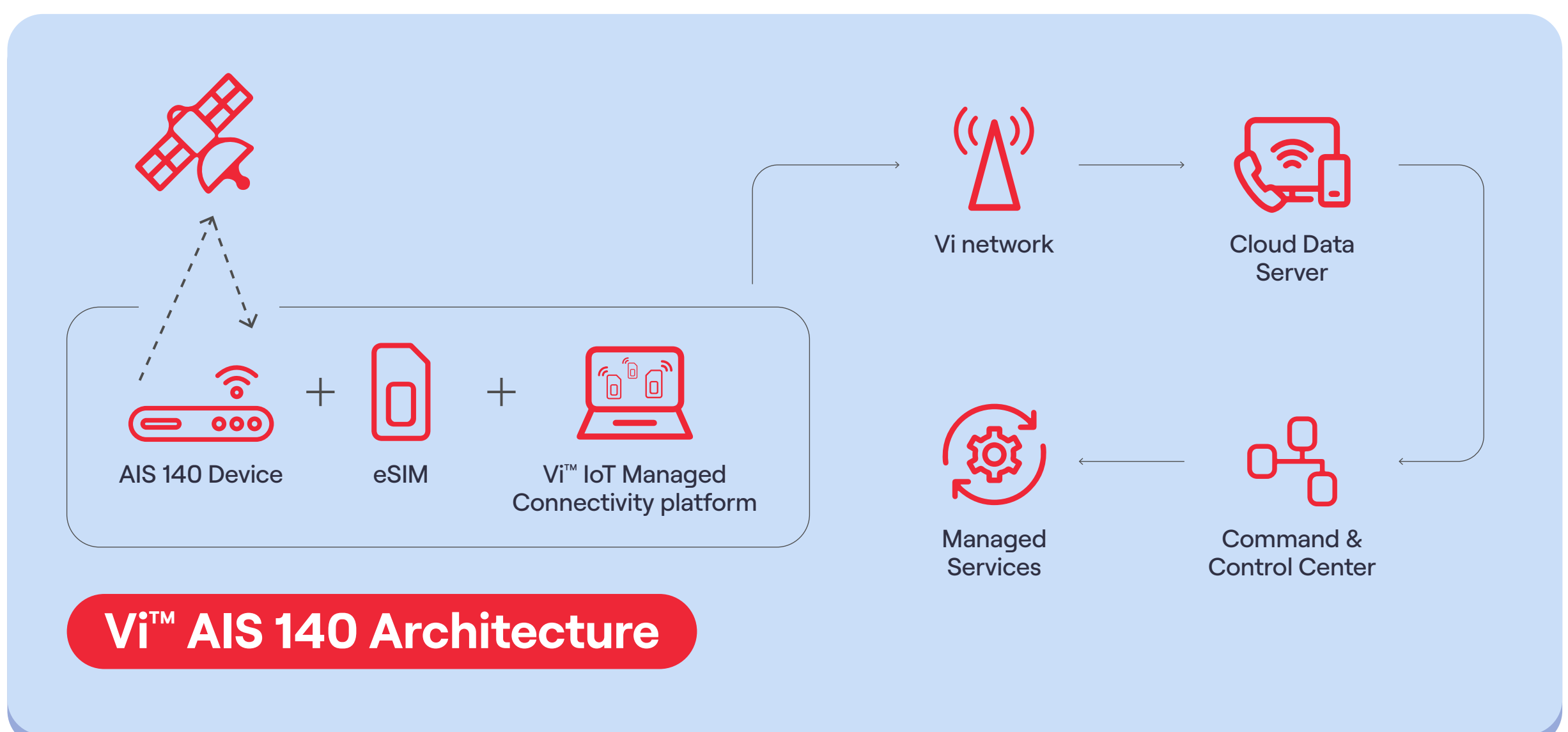

**Command & Control Centre:** Ensures the area is equipped with emergency response systems to dispatch Emergency Services in case of mishap

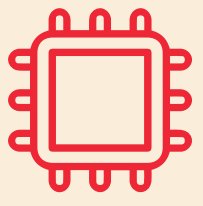
